NALMCO has partnered with the Alliance Safety Council (ASC) to administer, score, and analyze the Certified Senior GUV Technician (CS-GUVT) written examination. ASC, based in Baton Rouge, Louisiana, is a leading provider of certification exams for professional organizations.

EXAMINATION QUALIFICATIONS

The Certified Senior GUV Technician program aims to:

- Elevate standards within the lighting management industry by recognizing individuals who demonstrate technical competence and knowledge through a rigorous examination and adherence to standards of performance and conduct.
- Provide a voluntary recognition process for personal and professional achievement within the industry.
- Raise public awareness of qualified, ethical, and professional individuals in the lighting management field.
- Identify individuals with the technical expertise required in the lighting industry.
- Promote ongoing professional development among industry members.

Certification does not restrict or determine who can practice as a Certified Senior GUV Technician. The NALMCO Board of Directors expressly disclaims any intent to interfere with professional activities based on certification status. Absence of certification does not imply lack of qualification; it simply means the individual has not fulfilled CS-GUVT requirements or applied for certification.

EXAMINATION ADMINISTRATION/REGISTRATION

ADMINISTRATION

Examinations are conducted online through the Alliance Safety Council. Candidates can take the exam from their office or home at their convenience. Exams must be completed within 90 days of submitting the application and fee. The practical portion of the exam must be completed within one year of taking the written exam.

REGISTRATION AND TESTING PROCESS

1. Review the CS-GUVT Candidate Handbook before applying for the examination.
2. Enroll and pay for the CS-GUVT program on the NALMCO website (www.nalmco.org).
3. After processing your application and payment, you will receive an email regarding your testing session. This is the first part of a two-part process. Ensure your email system accepts emails from memberservice@nalmco.org. The email will provide your Username, Password, and the URL to access the exam online.
 - Alliance Safety Council recommends a high-speed internet connection with a minimum download speed of 250k.
 - Internet Browser (Google Chrome works best, but if you are using Internet Explorer, version 8 or higher works best)
 - Flash 8 or above
 - 5 years or newer with 256 ram (3 years if possible)
4. The exam consists of 90 multiple-choice questions and must be completed within two (2) hours. A minimum score of 60% or higher is required to pass and advance to the second part of the certification process.
5. Once you achieve a score of 60% or higher on the written exam, you will become eligible to register for the practical exam. Practical exam dates will be posted on the NALMCO website as they are scheduled, and you will also receive an email notification when new dates are available.
6. You have 90 days from the date you receive exam access to complete the written exam. After passing the written portion, you have one year to complete the practical exam.
7. Upon completion of both the written and practical exams, you will receive a certificate of certification.

SCORES CANCELLED BY NALMCO OR ASC

NALMCO and Alliance Safety Council ensure the validity and integrity of reported scores. In cases such as computer malfunctions or candidate misconduct, scores may be considered suspect. NALMCO and Alliance Safety Council reserve the right to invalidate or withhold examination results if violations of their regulations are discovered after investigation.

LEARNING OBJECTIVES FOR THE CS-GUVT EXAMINATION

Germicidal Ultraviolet (GUV) technology has gained significant recognition as an effective method for disinfection of air and surfaces across various industries. With its proven ability to eliminate harmful pathogens, it has become an integral component in maintaining a safe and healthy environment for employees, customers, and the public. It is important to train professionals responsible for the design, installation, and maintenance of germicidal GUV luminaires. This training and certification program will serve as the steps toward educating the public on the proper and safe use of Germicidal GUV.

- Installation and Maintenance of UV-C Luminaires
- Design and Create Safe and Effective Layout

EXAMINATION FEES

CS-GUVT Application and One (1) Year Certification Fee: \$1700

CS-GUVT Retake Fee: \$50

CS-GUVT Annual Recertification Fee: \$75

Fees are not refundable or transferable.

PASSING THE EXAM

Upon passing the CS-GUVT examination, you are entitled to use the CS-GUVT credential. Within two (2) weeks of passing the practical portion of the 2-part exam, you will receive an email containing a link to print your certificate. Your achievement will also be recognized in Lighting Management & Maintenance (LM&M) magazine. Certification remains valid for one year, starting from January 1st of the year following your exam date.

Certification applies strictly to individuals. The CS-GUVT designation cannot imply certification for a firm and must always accompany the certified individual's name. Certified Senior GUV Technician (CS-GUVTs) may display their certification on company letterheads, business cards, or appropriate advertisements.

NALMCO will notify you in writing about your recertification deadline. Ensure NALMCO has your current address to receive these notifications promptly.

CREDENTIAL USAGE

After passing the exam, you may use the CS-GUVT credential after your name.

CONTINUING EDUCATION REQUIREMENTS

Continuous education is crucial for lighting professionals to adapt to industry advancements swiftly. To maintain certification, professionals must:

1. Pay a recertification fee by December 31 of the expiration year.
2. Accumulate 6 professional development hours (CEUs) every year.

Credits can be earned through NALMCO Certification Committee approved activities, including:

- Participation in NALMCO educational programs.
- Successful completion of industry-related courses at colleges and universities.
- Attendance at lighting industry conventions and conferences.
- Participation in educational programs of recognized industry organizations (e.g., NEMA, AEE, IES, BOMA, NECA, IUVA, and the University of Maryland).
- Other approved activities such as giving speeches, writing articles on lighting management, and completing relevant online courses. Proof must demonstrate relevance to the lighting management industry.

Recording CEUs in Your NALMCO Profile

1. Log into your NALMCO account.
2. Navigate to CEU Tracking
3. Select "Add Credit" and fill out each field. (One hour of training equals 1 CEU.)

SUSPENSION OR REVOCATION OF CERTIFICATION

- If a Certified Senior GUV Technician fails to accrue the required professional credits through continuing education, their certification will lapse. Exceptions may be considered by the Certification Committee in cases of extenuating circumstances that can be reasonably addressed.
- Violation of the NALMCO Code of Ethics may result in certification revocation. The certified professional will be granted a hearing by the Certification Committee, receiving written notice of the complaint, hearing details, and the opportunity to present their perspective. Notice will be provided at least thirty (30) days prior to the hearing.
- Misuse of the CS-GUVT designation implying company-wide certification or corporate accreditation will lead to certification revocation for the involved individuals upon completion of a hearing. Evidence and testimony will substantiate the charges. Individuals and their companies will receive written notice thirty (30) days before the hearing.

EXAMINATION RETAKES

If you do not pass the examination, you have the option to pay a \$50 retake fee and attempt the exam again.

REFUNDS

Registration fees are non-refundable.

Managing Test Anxiety

While a moderate level of anxiety can enhance performance, severe anxiety may impair it. If you often experience severe test anxiety, consider developing coping strategies to harness your tension constructively.

Before the exam day, visualize and mentally rehearse the testing environment with a positive and calm mindset. Practice deep-breathing techniques and take breaks to stretch, which can alleviate both physical and mental stress. If needed, imagine calming scenarios and using positive affirmations.

Maintain a healthy diet, avoid excessive alcohol, and ensure regular sleep in the days leading up to the exam to optimize physical readiness. Ultimately, thorough preparation through a well-structured study plan is the most effective way to manage anxiety.

Tips for Taking the Examination

Manage your time effectively; aim to complete more than half of the questions in the first half of the allotted two hours. Take brief breaks to relax your eyes and stretch.

- Read each question carefully and focus on what is being asked.
- Review all answer options before making your selection; choose the most appropriate response.
- Avoid overanalyzing or making assumptions beyond the information provided in the question.
- Exercise caution with questions containing terms like “not,” “except,” or “least,” as these require identifying exceptions.
- Pay attention to key words such as “best,” “most,” “primary,” or “usually” to guide your answer selection.
- When guessing, use the process of elimination to narrow down choices and make an educated guess.
- Answer every question as there is no penalty for incorrect answers; guessing increases your chance of selecting the correct response.

These strategies will help you approach the exam confidently and effectively manage test-taking challenges.
